**AN ORDINANCE OF THE TOWN OF OXFORD TO AMEND CHAPTER 8 OF THE OXFORD TOWN CODE TITLED “VEHICLES AND TRAFFIC” BY ADDING SECTION 8.6 TITLED “PARKING/STORAGE OF VEHICLES IN FRONT YARD PROHIBITED”**

WHEREAS, the Town of Oxford is authorized by the Maryland Code Ann. Local Government Article § 5-202 to adopt such ordinances not contrary to the Constitution of Maryland, public general law, or public local law as it deems necessary to assure the good government of the municipality, to preserve peace and order, to secure persons and property from damage and destruction, and to protect the health, comfort and convenience of the citizens of the municipality; and

WHEREAS, the Commissioners of Oxford are authorized to provide for the publication and codification of all laws, ordinances, resolutions, or regulations adopted by the municipality; and

WHEREAS, the Commissioners have determined that it is desirable and in the public interest to amend Chapter 8 of the Oxford Town Code, titled “Vehicles and Traffic” to add Section 8.6 to prohibit the storage or parking of vehicles in the front yard of any property facing a street, unless it is parked in a driveway or designated parking area.

NOW, THEREFORE, the Commissioners of Oxford hereby ordain as follows:

**Section 1.** The Oxford Town Code, Chapter 8 is hereby amended by adding a new Section 8.6 titled “Parking of Vehicles in Front Yard Prohibited”, as follows:

***Section 8.6. Parking/Storing of Vehicles in Front Yard Prohibited***

***No automobile, boat, trailer, camper, jet ski, all-terrain vehicle, or other vehicle shall be parked, located or stored in a front yard of any property facing a street, unless it is parked in a driveway or designated parking area. A violation of this section shall constitute a municipal infraction pursuant to Chapter 1, Section 1.10.B of the Town Code.***

**Section 2.** This Ordinance shall take effect on the \_\_\_\_ day of \_\_\_\_\_, 2018.

**Section 3.** This ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect twenty (20) days from and after the date of its final passage and adoption.
